BACKGROUND CLEARANCE/CRIMINAL HISTORY CHECKS

OSG is committed to the protection of all people who are associated with its programs, such as registered scouts, volunteers, guests, and other organization members. Safety is the highest priority. OSG shall conduct criminal history checks of all registered Rovers (18 years of age and older) and Non-Rover Adults. These checks will be carried out at the time a person joins the organization and annually thereafter upon re-registration. OSG will carry out these checks in a fair, consistent, and non-discriminatory manner, complying with all applicable state and federal laws, including the Fair Credit Reporting Act. Criminal history check findings shall be assessed in a fair, impartial and confidential manner. Full background assessment policies furnished upon request.

Criminal history checks are handled by a third party service, **Sterling Volunteers**. OSG will not accept criminal history checks from any other service. Additionally, in order to comply with Pennsylvania law (2015 Act 15), all Rovers volunteering for leadership positions in 64th Brandywine must also complete the state-required 3 part clearances to volunteer with children. **Complete instructions for background check and additional clearances will be provided via email after registration.**

MEDICAL RELEASE AND LIABILITY WAIVER

Terms and Conditions: For purposes of this agreement (also referred to as Contract), the following applies throughout the document in consideration of the use of property, facilities, programs and/or services of the parties covered in this agreement. The parties covered by this contract applies to the releases, indemnifications and liability waivers in this contract. To the degree any provision in this contract is unenforceable for any reason, all other contract provisions shall remain in effect. The parties covered by this agreement include the below stated companies, programs and organizations as well as ALL PERSONS involved with these entities including, but not limited to, all other participants, volunteers, employees, leaders, officers and agents. The parties covered by this agreement (also referred to as Releasees) include: Outdoor Service Guides (OSG) and the OSG Scout Group 64th Brandywine. Contract term is one calendar year from signature. This contract is legally binding. The undersigned agrees as follows:

INITIAL

Medical Release: I agree to participate in the aforementioned Releasees programs, and should the need arise, do hereby authorize and consent to an x-ray examination, anesthetic, medical or surgical diagnosis rendered under general or special supervision of any member of the medical staff and emergency room staff licensed under the provisions of the Medicine Practice Act or a dentist licensed under the provisions of the Dental Practice Act and on the staff of any general hospital holding a current license to operate a hospital. It is understood that this authorization is given in advance of any specific diagnosis, treatment of hospital care being required but is given to provide authority and power to render care which the aforementioned physician in the exercise of his/her best judgment may deem advisable. I will not hold liable the parties covered by this agreement for medical aid rendered and will reimburse any person or organization for medical expenses incurred in my care. I will also provide my health insurance coverage information below, which I give permission to be given to the above mentioned immediate supervision of any member of the medical staff and/or emergency room staff.
